Well-Deserved Recognition! by: Suzanne Lewis-Johnson, CEO

In this month's newsletter, I'm excited to announce that the *National Organization for Victim Assistance (NOVA)* recognized Cortney Morgan, Founder and President of No More Trafficking, as a **NOVA Honorary Awardee in the category of Morton Bard Allied Professional Award.**

The Morton Bard Allied Professional Award recognizes outstanding leadership and tireless efforts in the advancement of crime victims' rights and the contributions of an individual in an allied profession to the field of victim advocacy. NOVA is the oldest national victim assistance organization of its type in the United States and is a leader in victim advocacy, education, and credentialing.

"Your unwavering dedication to assisting and empowering victims and survivors of crime is an inspiration to us all," NOVA Board President Jeannette Adkins wrote in the notification letter, "Most significantly, your extraordinary compassion, leadership and ingenuity in your work has helped countless victims and survivors begin to heal in the aftermath of a crime."

Cortney graduated Magna Cum Laude from the Georgetown Law Center. Early in her career with the US Department of Labor, she noticed a wide variety of programs serving people who had been trafficked overseas, with comparatively little attention paid to trafficking within the United States. Recognizing that systems are struggling to communicate with each other and close gaps in service to the trafficked and vulnerable, she founded No More Trafficking in 2012.

Cortney continues to serve as principle in the Law Office of Courtney Morgan, serving within and advising court systems, championing protocols and processes that raise the level of service to the most vulnerable, and being a voice for individuals who too often are held back from reaching their potential.

Resetting the Conversation: Realities of Human Trafficking (part 1 of 2)

Aiming to bring understanding reflective of the REALITIES of human trafficking, Suzanne spoke at an event hosted by the *InfraGard Northern Ohio Alliance* and *Our Savior Lutheran Hinkley*, with the *InfraGard National Alliance*, a non-profit partner of the FBI helping to protect U.S. infrastructure. This *NMT* series will highlight segments of the event to lay a foundation of **truth** and **accuracy** about trafficking and how it begins. We'll explore: Where does it happen? What does it look like? Who is responsible? How will we stop it?

Truth must always be our starting point - to understand, correct course, and establish freedom. As Suzanne said in the presentation, evil's primary weapon is <u>deception</u>. Evil advances when truth is taken off-track, distorted, or ignored. Let's begin with a few basic realities of human trafficking.

REALITY #1 - Human trafficking occurs when a person induces sex or labor through force, fraud, or coercion. REALITY #2 - Human trafficking is present right under our noses throughout all sectors of society. REALITY #3 - Human trafficking is preceded by a person's vulnerability (coming out from under the protection of truth), and then carried out when that person's vulnerability is exploited with evil intent (creating a false narrative that mimics truth).
